2. Section 2, Clause 2.1 (Eligibility Criteria), sub-clause (c), page 10 — "The Agency should have full-fledged Office in Delhi." will be read as

"The agency should have a fully serviceable office in Delhi/NCR".

Section 2, Clause 2.1 (Eligibility Criteria), sub-clause (d), page 10 –
 "Should have handled a minimum of 3 projects for Social Media in the last 3 years.
 (Work orders to be submitted as per annexure IV)" will be read as

"The agency should have handled a minimum of 3 projects for Online / Internet Social & Digital Media Services (excluding paid media services) in the last 3 years. (Work orders to be submitted as per annexure IV)"

4. Section 3, Clause 3.1.2 (Technical Evaluation), sub-clause (Parameter 1), page 14 – "Relevant experience in online Social Media Management for Government/ PSUs/ Private Sector/ Brands with a minimum Work Order/ Project value of INR 20,00,000/- in the last 3 years. Documents required: Work orders to be submitted for proof" will be read as

"Relevant experience in Online / Internet Social & Digital Media Services (excluding paid media services) for Government/ PSUs/ Private Sector/ Brands with a minimum Work Order/ Project value of INR 20,00,000/- in the last 3 years. Documents required: Work orders to be submitted for proof)".

- 5. In case, the audited Balance Sheet, Profit & Loss A/c and Auditors Report for 2017-18 is not available, un-audited financial figures of F.Y. 2017-18 duly certified by the statutory auditor may be submitted.
- 6. The tender fee and the EMD is exempted for MSME/NSIC registered agencies as per revised GFR rule 170(i) dated 25.07.2017, subject to submission of valid registration certificate.
