## **CINE ARTISTES WELFARE FUND OF INDIA**

### **ELIGIBILITY CRITERIA**

- (a) Age – 50 years and above (Age Proof – Certified true copy of PAN Card or Voters Card or Aadhaar Card).
- (b) Annual income from all sources is below Rs.30,000/- per annum (Income Proof – copy of bank passbook of last three years of self to ascertain the financial status).
- (c) Must have performed in at least five films. (Performance Proof – Certified true copies of List of films performed, photographs of films, certificates from producer/director & newspaper/magazine cuttings)
- (d) Must not be performing currently in any type of film media (TV, Films, Short Film, Documentary, Advertisement, etc.).
- (e) Only Cine Artistes are eligible, Junior Artistes, Technicians, Musicians, etc., are not eligible to apply.

### **GENERAL**

1. Grant of Financial Assistance from the Trust Fund to any Cine Artiste is not as a matter of right. Assistance would be extended depending on the applicant satisfying the eligibility and also keeping in view the financial allocation available for the purpose. The Trust reserves the right to reject or accept any application without assigning any reason thereof.
2. Applications in the prescribed format must be filled up and must be duly recommended by the Union/Association to which the Cine artiste is/has been affiliated and to be forwarded to respective Secretary/Regional Secretary [mentioned at sr.no.3] along with latest two colour photographs.
