### SHORT FILM COMPETITION BY NFDC

## **Terms and Conditions**

By participating in the Competition, participants agree to be bound by, and are deemed to have read and understood these Terms and Conditions.

#### General Guidelines:

- 1. The Competition is only for Indian Citizens, who are amateur filmmakers and are currently students of High school, college & University (both private & public).
  - \* Amateur Filmmaker one who does films as a hobby, for creative urge but his/her major source of revenue should be from some other means.
- 2. Submission of the Short Film will start from 1" August 2019 to 31" August 2019
- 3. All entries for the Competition must be submitted to the Creative Corner Section of www.MyGov.in. Entries submitted through any other medium/ mode will not be considered for evaluation.
- 4. Entries open only for Short Film with duration of maximum 3 minutes.
- 5. The Short Film can be made in any one of 22 official Indian languages with transcript (in verbatim) in Hindi /English.
- 6. The content of the Short Film should be suitable for Universal viewing.
- 7. The theme of the films should be, as suggested below:
  - a. "The future depends on what you do today"
  - b. "Freedom is being you, without anyone's permission"
  - c. "I love my Freedom, I respect my Freedom"
- 8. Participant is to make sure that his/her profile is accurate and updated since NFDC will be using this for further communication. This includes details such as
  - Name.
  - Identity Card Students Photo ID only with relevant dates shown (or signed letter from the Principal of the current institution), and
  - Phone number.
  - Entries with incomplete profiles will not be considered.
- 9. Only one person will be awarded. The participant must be the same person who has conceptualized and Shot the Short Film and plagiarism will not accepted. Strict penal action will be taken against any violation of this clause not limited to disqualification from the competition.
- 10. The top 5 entries which receive a prize for Short Film will be the intellectual property of the National Film Development Corporation (NFDC) and the winner cannot exercise any right over it, after acceptance of the prize.
- 11. The prize-winning Short Film is meant to be used by the NFDC for promotional and display purposes and also for any other use as may be deemed appropriate for the initiative and not for any commercial purpose.
- 12. Please note that the Short Film must be original and should not violate any provision of the Indian Copyright Act, 1957.
- 13. The Short Film must not contain any provocative, objectionable or inappropriate content since the short film is intended for viewing by all age groups.

- 14. Anyone found infringing on others copyright will be disqualified from the Competition. NFDC does not bear any responsibility for copyright violations or infringements of intellectual property carried out by the participants.
- 15. NFDC reserves the right to cancel or amend all or any part of the Competition and/or the Terms & Conditions/ Evaluation Criteria. However, any changes to the Terms & Conditions/ Evaluation Criteria, or cancellation of the Competition, will be updated/ posted on contest page on the MyGov platform. Participants are responsible to keep themselves informed as to any changes in the Terms & Conditions/Evaluation criteria stated for this Competition.
- 16. The Participant(s) represent(s) and warrant(s) that he/she will comply with all applicable Indian laws. The Participant(s) shall not disclose and/or use any information, if doing so is in violation of any obligation against confidentiality.
- 17. By registering for participation in the Competition, the Participant(s) warrant that:
  - i) They have complied with these terms and conditions;
  - ii) Their name is original;
  - iii) Their entry does not infringe any intellectual Property Rights of any third party;
  - iv) Any current employer and/or learning institution that the participant is employed by or enrolled with will have no claim on the Short Film developed and submitted.
- 18. NFDC reserves the right to reject any entry without giving any reason.
- 19. NFDC accepts no responsibility for any damage, loss or injury of any kind suffered by any participants in entering the Competition, including as a result of any participant winning or not winning any prize.
- 20. NFDC will not be held responsible if the participants are not able to upload their entries on MyGov portal before the last date & time of submission for any reason whatsoever.
- 21. Entries must be made by the closing date and in the manner set out in the Competition's Terms and Conditions. Failure to do so will result in disqualification.
- 22. Multiple submissions of entries by the same participant will not be considered and the first entry received would be considered.
- 23. The selected Top 5 entries will be awarded with Cash Prizes and Certificates:
  - a. 1s Prize INR 40000/-
  - b. 2<sup>nd</sup> Prize INR 25000/-
  - c. 3rd Prize INR 15000/-
  - **d.** 4th Prize INR 5000/-
  - e. 5th Prize INR 5000/-
- 24. The last date for submission of entry is 31<sup>st</sup> August 2019.
- 25. The Selected and shorlisted entries will be uploaded on MyGov. Date will be informed separately.
- 26. The Panel of Jury, who evaluate the Competition will be Experts on Film Making.
- 27. The results of the Competition will be declared on MyGov portal.
- 28. The courts of Delhi shall have exclusive jurisdiction to deal with and decide any dispute whatsoever arising out of this competition.
- 29. Employees of NFDC and their immediate Family members and Relatives are not eligible to participate in the competition.

1. Students will have to upload a copy of valid school/college/university ID along with the entry.

2. The technical details of the Short Film with specific details, to be the last frame of the submitted short film for the competition. These details will not be inclusive of the 3 minutes assigned for the short film competition.

- 4. NFDC will have all intellectual rights over the winning entries for usage in a way felt appropriate by it. Winning participant will have no right or claim on the submitted entries once the winners are declared.
- 5. In case of any dispute arising out of the competition/its entries/ winners, Managing Director, NFDC decision will be final.
